ADMISSION NOTIFICATION FOR FIRST YEAR OF POST SSC DIPLOMA IN ENGINEERING & TECHNOLOGY 2016-17

In exercise of the powers conferred by section 23 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. XXVIII of 2015), the Government of Maharashtra has notified the rules 'the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions to the Full Time Professional Diploma Technical Courses) Rules, 2016' to regulate the admissions to the First and Direct Second Year of Full Time Professional Diploma Technical Courses (Engineering and Technology, Pharmacy, Hotel Management and Catering Technology). These rules are also applicable for admissions in Government and Government Aided institutions vide Government Resolution of Higher & Technical Education Department No. TEM-2016/CR 536/TE-4 Dated 15th March 2016.

This notification is being issued for Online Registration, Documents Verification and Application Form Confirmation at Facilitation Centers (FC) by aspiring candidates for admissions to First Year of Full Time Diploma Courses in Engineering and Technology in the Government, Government Aided and Unaided Private Professional Educational Institutions for the Academic Year 2016-17 in the Maharashtra State. The Director, Technical Education shall act as a Nodal Officer to carry out the admissions under the supervision & control of the Competent Authority.

Aspiring candidates are hereby informed to read the aforesaid Act and Rules published on <http://www.dtemaharashtra.gov.in/poly2016>.

Eligibility Criteria for Admission according to various types of candidature:

Maharashtra State Candidates/ Jammu & Kashmir Migrant Candidates/ All India Candidates/ Government of India nominee Candidates / Minority Candidates	NRI/ OCI / PIO, Children of Indian workers in Gulf Countries, Foreign National Candidates
(i) The Candidate should be an Indian National; (ii) Passed SSC or its equivalent examination from recognized institution with at least 35% aggregate marks. (iii) Candidates who have passed Maths/ Mathematics (code 71 for Maharashtra State Board) and Science & Technology (code 72 for Maharashtra State Board) are only eligible for admission. For Minority candidates : In addition to above (i), (ii) & (iii) Candidate must be Maharashtra Domiciled and belonging to particular linguistic or religious minority community (Muslim/ Buddhist/ Christian/ Shikh/ Parsi/ Jain) from within the state and as notified by the Government.	(i) Passed SSC or its equivalent examination from recognized institution with at least 35% aggregate marks. (ii) Candidates who have passed Maths/ Mathematics (code 71 for Maharashtra State Board) and Science & Technology (code 72 for Maharashtra State Board) are only eligible for admission.

Important Note:-

- All types of candidates, including minorities, aspiring for admission under CAP seats, it is **mandatory** to get registered and get Documents Verified and Confirmed at Facilitation Center.
- As per the Rule No 3 & 12 of the notified rules, candidates aspiring for admission for Institutional Quota, vacant seats after CAP, Supernumerary Seats for Children of NRI/OCI/PIO, Children of Indian workers in Gulf Countries, Foreign National Candidates, it is a **prerequisite & mandatory** to get documents verified and confirmed at Facilitation Centers.
- Only those Candidates who have verified and confirmed documents at Facilitation Centers and having CAP Merit number shall be eligible for admission for all types of seats/quota.

Online Registration for Admission:-

1.1 The candidates should apply online on www.dtemaharashtra.gov.in/poly2016 as per schedule and fill the Online Application Form step by step.

1.2 The candidates are required to purchase the Application Kit with Information Brochure from the nearest Facilitation Centre as given below. NRI/OCI/PIO, Foreign National Candidates shall pay the required fees only by Credit Card/Debit Card/Net Banking as given below-

Schedule of activities of admission round for J & K Migrant, Children of NRI/OCI/ PIO, Children of Indian workers in Gulf countries, Foreign National as the case may be will be notified separately on website.

Important Instructions for candidate:

1. The List of the institutes identified as Facilitation Centers (FC) and Admission reporting Centers (ARC) is available on the website.
2. The candidates are required to produce the documents in original for verification and Confirmation of Application Form at Facilitation Center (FC).
3. Candidates are advised to keep the necessary documents ready and scan all the documents.
4. If candidates fail to confirm online filled Application Form at Facilitation Center (FC), then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission for both CAP as well as non CAP process.
5. All Backward Class candidates excluding SC & ST should produce Non Creamy Layer certificate valid up to 31st March 2017 at the time of verification of documents at Facilitation Center (FC), if these candidates are not able to produce the Non Creamy Layer certificate, then such candidates will be treated as GENERAL category candidates and such candidates will not be able to claim Reserved seats in the admission process.
6. Application received after the due date from candidates belonging to J & K Migrant, NRI/OCI/PIO, Children of Indian workers in Gulf countries, Foreign National categories will be summarily rejected and no correspondence will be entertained in this regard. Such Candidates will get the Receipt-cum-Acknowledgement through their login after verification & confirmation of application form.
7. Candidates who have purchased application kit as a reserved category candidate but unable to produce required documents for reservation claim during documents verification, shall have to pay difference amount of fees of Rs. 100/- at the Facilitation Center (FC) in cash.
8. Once the candidate confirms his/her Option form online through his/her Login for the respective admission rounds, Candidate will not be allowed to change/cancel the option/preference submitted under any circumstances.
9. **The Seat Acceptance fees of Rupees 3000/- for General Category, VJ/DT, NT, SBC/OBC category and Rupees 1000/- for SC, ST category candidates is to be paid by Demand Draft in favour of 'Commissioner, State CET Cell, Maharashtra State, Mumbai' payable at 'Mumbai'. Candidates are advised to get this demand draft ready well in advance so as to avoid delay due to Bank holidays.**

General Notes:

1. Candidate can avail the facilities for filling online application form, scanning documents free of cost at Facilitation Centre (FC).
2. All FC's shall remain open on all days including holidays and Sundays for submission & confirmation of application form during the schedule.
